Police Secondary Eligibility Register Testing – Chief Eul discussed using Stanard and Associates to conduct the written test for the Secondary Eligibility List and the possibility of waiving the fees for the applicants. He also discussed options of having the applicants either take the test on-line or in person.

Police Sergeant Promotion Testing – Chief Eul gave an overview of the Police Sergeant Promotion Test process using Resource Management Associates. The list of books for the exam has been given to the applicants and the Merit and Efficiency portion of the testing process will be the next step. The written test will be held on August 24, oral interviews will be September 13-17, Assessment Center Orientation is October 5<sup>th</sup> with the Assessment Center Exercises conducted October 11-13, 2021.

<u>Review Executive Session Minutes</u> – According to the Illinois Open Meetings Act, Executive Session Minutes should be reviewed twice a year to determine if they should be released to the public. After a brief discussion, the Board determined that the Executive Session Minutes should remain closed.
